AN ORDINANCE CREATING THE NUEVA ERA MULTI-SECTORAL STI, HIV AND AIDS COUNCIL AND ITS TECHNICAL WORKING GROUP, FOR THE PREVENTION AND CONTROL OF SEXUALLY TRANSMITTED INFECTION HUMAN IMMUNODEFICIENCY VIRUS (HIV) AND ACQUIRED IMMUNE DEFICIENCY SYNDROME (AIDS), DEFINING ITS FUNCTIONS, PROVIDING RESPONSE, APPROPRIATING FUNDS AND OTHER RELATED PURPOSES

WHEREAS, patients with sexually transmitted infection, STI, HIV and AIDS diseases in our country have been increasing for the past years;

WHEREAS, to prevent the rampant increase affected by these alarming diseases, and in order to keep our constituents well informed and fully aware, there is a need to create a working committee for the information dissemination of the ill effects of sexually transmitted diseases;

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF NUEVA ERA, IN A REGULAR SESSION ASSEMBLED, THAT:

SECTION 1. TITLE - This ordinance shall be known as "Creating the Nueva Era Multi-Sectoral STI, HIV and AIDS Council and its Technical Working Group (TWG)"

SECTION 2. PURPOSE - The Council is created to be the central advisory, planning and policy making body for:

- (a) the prevention and control of Sexually Transmitted Infection (STI), Human Immunodeficiency Virus (HIV) and Acquired Immune Deficiency Syndrome (AIDS);
- (b) defining the functions of the Council and its working group; and
- (c) providing response through programs, projects and other related initiatives.

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF NUEVA ERA, IN A REGULAR SESSION ASSEMBLED, THAT :
