**Series 2015**

**AN ORDINANCE APPROVING THE IDENTIFIED PROJECT FUNDED UNDER RA 7171 (SHARE FROM CY 2012 EXCISE TAX ON LOCALLY MANUFACTURED VIRGINIA TYPE CIGARETTE).**

**WHEREAS**, the Municipality of Nueva Era has a share in the amount of Ten Million Five Hundred Fifty Six Thousand Four Hundred Forty Nine Pesos (10,556,449.00) from the CY 2012 Excise Tax on locally manufactured Virginia-Type cigarette under Republic Act 7171 chargeable against the allocation of the local government units as per Local Budget Memorandum No. 69 dated February 16, 2015;

**WHEREAS**, the Local Government Unit has identified project intended to uplift the economic condition of tobacco farmers;

**WHEREFORE**, be it enacted by the Sangguniang Bayan, that:

**SECTION 1. TITLE.** This shall be known **AN ORDINANCE APPROVING THE IDENTIFIED PROJECT FUNDED UNDER RA 7171 (SHARE FROM CY 2012 EXCISE TAX ON LOCALLY MANUFACTURED VIRGINIA TYPE CIGARETTE).**

**SECTION 2. PROJECT TO BE IMPLEMENTED.** The project identified for implementation under this ordinance is the **IMPROVEMENT/CONCRETING OF ROAD AT BARANGAY UGUIS, NUEVA ERA, ILOCOS NORTE.**

**SECTION 3. AUTHORITY TO IMPLEMENT.** The Local Chief Executive is hereby authorized to implement the project covered under this ordinance.

**SECTION 4. EFFECTIVITY.** This ORDINANCE shall take effect immediately.


**FINDINGS/OBSERVATIONS:**

2. The identified project on said ordinance will benefit the tobacco farmers that conforms to the provisions on the utilization of RA 7171 fund.




Sir:

We are returning herewith Municipal Resolutions & Ordinance of the various Municipality with the following recommendations/observations:


