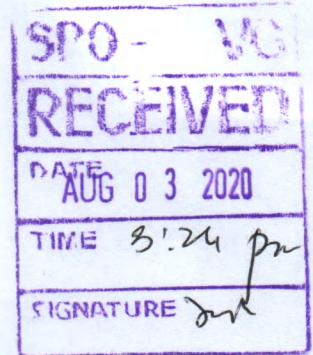

MUNICIPAL ORDINANCE NO. 2020-32

AN ORDINANCE PRESCRIBING THE PRECAUTIONARY MEASURES (MANDATORY PROPER WEARING OF FACEMASK, SOCIAL DISTANCING, BACK-RIDING ON MOTORCYCLES AND PROHIBITION OF MASS GATHERINGS AMONG MINORS IN PUBLIC PLACES) DURING THE COVID-19 PANDEMIC AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

WHEREAS, the outbreak of the Corona Virus Disease COVID-19 had been declared pandemic by the World Health Organization (WHO) and has affected millions of patients and claimed lives among the affected patients worldwide;

WHEREAS, one of the Fundamental Powers of the State is the Police Power to make, ordain, establish all manner of wholesome and reasonable laws for the good and welfare of the people and in compliance to the declaration of His Excellency President Rodrigo Roa Duterte on Enhanced Community Quarantine;

WHEREAS, Sec. 4 of Republic Act 11469 also known as the Bayanihan to Heal as One Act ensures that LGUs are acting within the letter and spirit of all the rules, regulations and directives issued by the national government to address the COVID-19 pandemic;

WHEREAS, the intent of preventing further increase in Covid-19 cases, the Department of Interior and Local Government issued Memorandum Circular No. 2019-181 re: Disiplina Muna National Advocacy Campaign and MC No. 2020-071 on mandatory wearing of facemasks or other protective equipment in public areas, and encouraged Local Government Units " to enact measures instituting individual discipline among the constituents in order to beat and prevent the transmission of Corona Virus Covid-19 disease;

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Nueva Era, Ilocos Norte by virtue of the powers vested in law, in session duly assembled that:

SECTION 1. Title. This ordinance shall be known as "AN ORDINANCE PRESCRIBING THE PRECAUTIONARY MEASURES (MANDATORY PROPER WEARING OF FACEMASK, SOCIAL DISTANCING, BACK-RIDING ON MOTORCYCLES AND PROHIBITION OF MASS GATHERINGS AMONG MINORS IN PUBLIC PLACES) DURING THE COVID-19 PANDEMIC AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

SECTION 2. DEFINITION OF TERMS: As used in this ordinance, terms are defined hereunder:

1. **Disiplina Muna Advocacy Campaign** – a concrete, conscious and creative effort to promote the vital contribution of the citizenry in both peace and development in the communities.
2. **Backriding on motorcycle** – Riders between the driver and a passenger in one motorcycle.
3. **Minor** – person under age below 18 years old.

4. Mass gathering among minors in public places – gathering of more than three minor persons in public places.
5. Social distancing – a distance of one (1) meter between other persons in public places.
6. Facemask – a protective mask for face made of medical, reusable, or homemade material.
7. Violator – anybody whether natural or juridical entity who commits violation on national laws or ordinances whether resident or non-resident within the Municipality of Nueva Era.
8. Public Places-includes but not limited to: public streets, parks, plaza, covered court, commercial areas such as restaurants, stores, resorts, and other recreational areas.

SECTION 3. Coverage. This ordinance shall cover all residents of the municipality going out in public.

SECTION 4. The following precautionary measures/minimum health standards shall be strictly observed and implemented:

- A. The proper wearing of facemask of persons whenever they are allowed to go out of their home is mandatory at all times.
- B. Social distancing of one meter shall be maintained in all public places, offices and other places where essential needs are acquired and served.
- C. Motorcycle Back-riding is allowed only for couples living in the same household provided there shall be a physical barrier between the driver and passenger and a valid ID or proof that said persons are living together or married to one another is presented. Provided further that a minor will be fetched to and from the hospital and a motorcycle is the only vehicle available in the family.
- D. Minors are prohibited in mass gatherings in any public place such as streets, hall, parks and plaza, resorts, commercial areas and other recreational areas.

SECTION 5. PENAL PROVISION. Any person violating any of the provisions of this ordinance shall be imposed for a fine of:

1st OFFENSE - Php1,000.00
2nd OFFENSE - Php1,500.00

3rd OFFENSE AND SUCCEEDING OFFENSES - Php2,500.00 or both fine and imprisonment of not more than six months or at the discretion of the court.

FOR MINORS:

12 years old to less than 18 years old:

1st OFFENSE - Community Service for 4 hours
2nd OFFENSE- Community Service for 6 hours
3rd OFFENSE AND SUCCEEDING OFFENSES- Community Service for 8 hours


BELOW 12 YEARS OLD:

1st OFFENSE - Community Service of parents of minors for 4 hours
2nd OFFENSE- Community Service of parents of minors for 6 hours
3rd OFFENSE AND SUCCEEDING OFFENSES- Community Service of parents of minors for 8 hours

SECTION 6. This ordinance shall be enforced by the Persons in authority such as Local Chief Executive, Punong Barangays, School Heads, and Agents of Persons in Authority such as members of the PNP, AFP, BFP, CAGU, Barangay Tanods and those authorized by appointment of the Local Chief Executive .

SECTION 7. The implementation of this ordinance shall be valid during the pandemic crisis and shall be lifted upon the pronouncement of the World Health Organization (WHO) or higher authorities that the pandemic is over

SECTION 8. REPEALING CLAUSE. All Ordinances, resolutions and other issuances inconsistent with the provision of this ordinance are hereby repealed and modified accordingly.



SECTION 9. SEPARABILITY CLAUSE. If for any reason any provision of this Ordinance is declared invalid or unconstitutional by appropriate agency or office, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 9. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.

FINDINGS/OBSERVATIONS:

The above-mentioned subjects treat with the mandate of the Memorandum dated July 28, 2020 issued by the DILG Secretary with the subject "ENACTMENT AND/OR AMENDMENT OF EXISTING LOCAL ORDINANCES TO INCLUDE PENAL PROVISIONS TO STRENGTHEN IMPLEMENTATION OF QUARANTINE AND HEALTH SAFETY STANDARD PROTOCOLS TO CONTAIN COVID 19", and all other previous issuances from the Secretary of the DILG.

In view of the foregoing and as the Provincial Governor has consistently revised Executive Orders to conform to recent national issuances and referred to Provincial Ordinance No. 22-2020 dated April 20, 2020 "An Ordinance Imposing Penalties for Violation of Executive Orders, Issuances and Directives issued in Relation to Proclamation No. 922 Declaring the Philippines Under a State of Public Health Emergency by Reason of the Corona Virus Disease (Covid 19), as amended", in the imposition of penalties against violators, the Sangguniang Panlalawigan has consistently ruled that penalties imposed under ordinances enacted by inferior sanggunians inconsistent with PO No. 22-2020 are considered invalid as inferior sanggunians

cannot validly amend or supersede an ordinance enacted by the Sangguniang Panlalawigan which are enforceable in all component LGUs of the Province.

RECOMMENDATION/S:

The committees jointly recommend that the Ordinances as above-mentioned from the Municipalities of Badoc, Bangui, Banna, Currimao, Dingras, Nueva Era, Paoay, Piddig, San Nicolas, Sarrat and Solsona and the cities of Batac and Laoag, are hereby declared **VALID IN PART** but the penalties imposed for acts punishable under Provincial Ordinance No. 22-2020, as amended, with penalties inconsistent with the said Provincial Ordinance, as amended, are declared **INVALID IN PART**.


