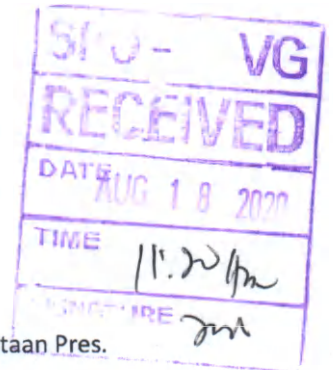

MUNICIPAL ORDINANCE NO. 2020- 33

AN ORDINANCE DECLARING CERTAIN PARCELS OF LAND SITUATED WITHIN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE TO BE DESIGNATED AND NAMED AS MUNICIPAL INSTITUTIONAL ZONE OF NUEVA ERA AND PROVIDING FUNDS FOR THEIR ACQUISITION THEREOF.

WHEREAS, pursuant to Republic Act 7160 otherwise known as the Local Government Code of 1991 mandates the revision/upgrading of the Comprehensive Land Use Plan (CLUPs) in every Local Government Unit;

WHEREAS, the Comprehensive Land Use Plan and Zoning Ordinance are envisioned to ensure the judicious allocation of lands for the growing population and to satisfy the needs of the community requiring alteration of existing land uses and utilization of environmental resources;

WHEREAS, the Municipal Government of Nueva Era has identified certain parcels of land situated within the municipality and ideal areas for the establishment of institutional facilities responsive to the needs for community development;

WHEREAS, Section 19 of RA 7160 provides local government to exercise the power of eminent domain for public use, or purpose or welfare for the benefit of the poor and the landless, upon payment of just compensation, pursuant to the provisions of the Constitution and pertinent laws;

WHEREAS, consultations with all stakeholders and constituents in the different barangays had been conducted;

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Nueva Era, Ilocos Norte by virtue of the powers vested in law, in session duly assembled that:

SECTION 1. Title. This ordinance shall be known as the "AN ORDINANCE DECLARING CERTAIN PARCELS OF LAND SITUATED WITHIN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE TO BE DESIGNATED AND NAMED AS MUNICIPAL INSTITUTIONAL ZONE OF NUEVA ERA AND PROVIDING FUNDS FOR THEIR ACQUISITION THEREOF.

SECTION 2. PURPOSE, SCOPE AND COVERAGE. This ordinance shall apply to identified parcels of land located within the municipality to be designated and named as municipal institutional zone for community development.

SECTION 6. SEPARABILITY CLAUSE. If for any reason any provision of this Ordinance is declared invalid or unconstitutional by appropriate agency or office, the remaining provisions not affected thereby shall continue in full force and effect.

The Joint Committee Report hereby adopts the recommendation of the Office of Provincial Planning and Development Coordinator; thus:



To serve a primary basis for cases of reclassification. The update CLUP will automatically determine if such parcels of land are included/reclassified for a particular land use. This recommendation applies all cases of reclassification, as far as Nueva Era is concerned, until the update CLUP is officially approved.’”



SECTION 6. SEPARABILITY CLAUSE. If for any reason any provision of this Ordinance is declared invalid or unconstitutional by appropriate agency or office, the remaining provisions not affected thereby shall continue in full force and effect.
