### MUNICIPAL ORDINANCE NO. 2020-35

## AN ORDINANCE PRESCRIBING RULES AND REGULATIONS ON THE LEARNING CONTINUITY OF ACTIVE RESPONSE GRANT IN SUPPORT TO EDUCATION UNDER THE NEW NORMAL

**WHEREAS**, Sec. 4 of Republic Act 11469 also known as the Bayanihan to Heal as One Act ensures that LGUs are acting within the letter and spirit of all the rules, regulations and directives issued by the national government to address the COVID-19 pandemic;

WHEREAS, one of the Fundamental Powers of the State is the Police Power to make, ordain, establish all manner of wholesome and reasonable laws for the good and welfare of the people;

WHEREAS, under the new normal situation, in effect of the corona virus (COVID 19) outbreak, the Department of Education adopted the Modular Learning System as means of continuing education for pupils and students for the forthcoming school year;

**BE IT ORDAINED** by the Sangguniang Bayan of the Municipality of Nueva Era, Ilocos Norte by virtue of the powers vested in law, in session duly assembled that:

## SECTION 1. TITLE. This ordinance shall be known as "AN ORDINANCE PRESCRIBING RULES AND REGULATIONS ON THE LEARNING CONTINUITY OF ACTIVE RESPONSE GRANT IN SUPPORT TO EDUCATION UNDER THE NEW NORMAL"

SECTION 2. DEFINITION OF TERMS: As used in this ordinance, terms are defined hereunder:

- 1. Modular Distance Learning- involves individualized instruction that allows learners to use self learning modules
- 2. PTCA –Parent Teachers Community Association- group people particularly parents and teachers of pupils/students
- 3. On-line learning –refers to education that takes over the internet which is also known as e-learning.
- 4. Face to face learning- learning of pupils/students with interaction to teachers.
- 5. Barangay Officials includes those elected officials, the Punong Barangay, Barangay Kagawad, Sangguniang Kabataan Chairman, Barangay Secretary and Barangay Treasurer.
- 6. Barangay Volunteers -are those appointed Barangay Tanods and Barangay Health Workers.

SECTION 3. Coverage. This ordinance shall cover pupils/students enrolled, parents/guardians, Teachers and Barangay Officials and Barangay Volunteers.

SECTION 4. RULES AND REGULATIONS TO STRICTLY OBSERVE AS USED IN THIS ORDINANCE:

- 1. Face to face learning is discouraged in all schools of the municipality.
- 2. Materials for modular learning shall be provided jointly by DEPED and the Local Government Unit.
- 3. Distribution and collection of learning modules to pupils and students shall be done in close coordination with DEPED teachers. Barangay Officials and Barangay Volunteers.
- 4. Teachers shall monitor the pupils/students in their self learning of the modules at least once a week.
- 5. Parents/guardians shall take custody of the modular materials.
- 6. Minimum health protocols shall be strictly observed.
- 7. Teachers shall evaluate status of learning activities/output of pupils/students and furnish the Local Government Unit on the results of evaluation.
- 8. Parents shall provide comfortable learning area for their children (pupils/students) in their homes.
- 9. Pupils/Students who stay outside their homes during learning hours at 8:00-11:00 a.m. and 1:00-4:00 p.m. Monday to Friday, without any justifiable reason shall be invited and brought to the PNP office together with his/her parents/guardians for inquiry. The MSWDO, Concerned Adviser, Guidance Coordinator/School Heads shall give pieces of advise or reprimand to the truant student /pupil.

SECTION 5. The implementation of this ordinance shall be valid during the pandemic crisis and shall be lifted depending on the issuance and guidelines of the Department of Education and the higher authorities.

**SECTION 6. REPEALING CLAUSE.** All Ordinances, resolutions and other issuances inconsistent with the provision of this ordinance are hereby repealed and modified accordingly.

**SECTION 7. SEPARABILITY CLAUSE**. If for any reason any provision of this Ordinance is declared invalid or unconstitutional by appropriate agency or office, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.
