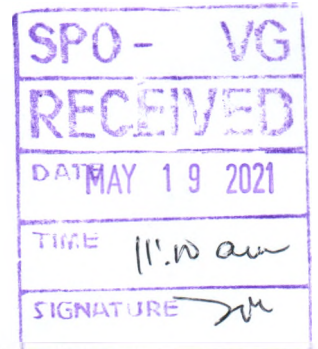

MUNICIPAL ORDINANCE NO. 41
Series of 2021

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2019-26 ENTITLED "AN ORDINANCE REVISING THE GENDER AND DEVELOPMENT CODE OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE TO INCORPORATE THE PROVISIONS OF REPUBLIC ACT 11313 OR SAFE SPACES ACT.

WHEREAS, Municipal Ordinance No. 2019-26 entitled "An Ordinance Revising the Gender and Development Code of the Municipality of Nueva Era, Ilocos Norte was enacted on October 21, 2019;

WHEREAS, DILG and Philippine Commission on Women JMC 2020-001 provides guidelines on the Localization of the Safe Spaces Act (RA 11313)

WHEREAS, pursuant to RA 7160 also known as the Local Government Code of 1991, local government units are mandated to promote the general welfare of their constituents;

NOW THEREFORE, be it ordained that:

SECTION 1. Insertion of a new section 10.1 and 10.2 under Section 10 Book II Final Provisions
Art. 1. New sections 10.1 and 10.2 are inserted to read as follows:

Section 10.1. SEXUAL HARASSMENT OF WOMEN IN PUBLIC SPACES. The following which constitute sexual harassment in public places shall be penalized in accordance with the Revised Penal Code.

- a. Light violations – Cursing, wolf-whistling, catcalling, repeatedly asking for the number or dates, or calling a woman in public with words having dirty connotations or implications which tend to ridicule, humiliate, or embarrass the woman such as but not limited to persistent telling of offensive jokes (taunting a person with constant talk about sex, sexual innuendoes, green jokes or other analogous statements)to someone who finds them offensive, demeaning, threatening or humiliating.
- b. Medium violations – Stalking, making offensive mouth, tongue, lip, hand or body gestures at someone, or other analogous gestures or visual harassment directed at a woman for the sexual gratification of the perpetrator or with the intention to demean, sexually harass, intimidate or threaten a woman.

- c. Severe violations – Touching, pinching or brushing up against the body of a person unnecessarily, or deliberately; either directly or through clothing, of the genitalia, anus, groin, breast, inner thigh or buttocks, the introduction of any object into the genitalia, anus, or mouth of any person whether of the same or opposite sex, public masturbation, lascivious exhibition of the genitals or pubic area of a person or other analogous acts of lasciviousness directed at a woman for the sexual gratification of the perpetrator or with intention to demean, sexually harass, intimidate or threaten a woman.

SECTION 10.2. **Penalty Clause** – Any violation of the provision of this section shall be penalized by a fine of not less than Two Thousand Pesos (Php2,000.00) but not more than Two Thousand five hundred Pesos (Php2,500.00) or imprisonment at the discretion of the court.

(a) Implementation of penalties under this section are without prejudice to the provisions of the Revised Penal code and/or special laws as the case maybe.

SECTION 2. REPEALING CLAUSE. Any law, ordinance or executive order or portion thereof not consistent with the provisions of this ordinance is hereby deemed repealed or modified.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.




