



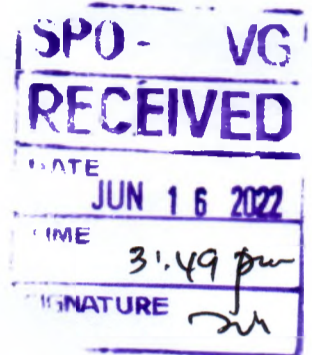

MUNICIPAL ORDINANCE NO. 50
Series of 2022

AN ORDINANCE DECLARING JUNE 19 EVERY YEAR AS JOSEPH B. ARZADON DAY IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE IN RECOGNITION OF THE GREAT AND SIGNIFICANT CONTRIBUTIONS OF THE LATE JOSEPH B. ARZADON ON THE CONSERVATION, PROTECTION AND MAINTENANCE OF ENVIRONMENT WITHIN THE MUNICIPALITY AND THE PRESERVATION AND PROMOTION OF THE INDIGENOUS PEOPLE'S CULTURAL INTEGRITY BEING THE TRIBAL CHIEFTAIN OF THE TINGGUIAN TRIBE IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, the late JOSEPH B. ARZADON had rendered 22 years of service in the national government, under the Department of Environment and Natural Resources as Forester, spearheading reforestation and afforestation projects in various parts of Ilocos Norte including Nueva Era in particular;

WHEREAS, the late JOSEPH B. ARZADON was the Tribal Chieftain of the Tingguian Tribe for over thirty years (30) who promoted the preservation of culture and the protection of ancestral domain in the municipality;

WHEREAS, he had also served the municipality as the Municipal Mayor (1988-1998), Municipal Vice Mayor (2001-2010) and Sangguniang Bayan Member (2010-2019) of Nueva Era and one of his advocacies is the upliftment of the economic well-being of the Nueva Eranians;

WHEREAS, the Local Government of Nueva Era recognizes the great and significant contributions of the Late JOSEPH B. ARZADON, who devoted most of his time, strength and it was his passion for the conservation, protection and maintenance of the environment of the municipality and some parts of the Province of Ilocos Norte;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that:

Section 1. SHORT TITLE: This ordinance shall be known as **AN ORDINANCE DECLARING JUNE 19 EVERY YEAR AS JOSEPH B. ARZADON DAY IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE IN**

RECOGNITION OF THE GREAT AND SIGNIFICANT CONTRIBUTIONS OF THE LATE JOSEPH B. ARZADON ON THE CONSERVATION, PROTECTION AND MAINTENANCE OF ENVIRONMENT WITHIN THE MUNICIPALITY AND THE PRESERVATION AND PROMOTION OF THE INDIGENOUS PEOPLE'S CULTURAL INTEGRITY BEING THE TRIBAL CHIEFTAIN OF THE TINGGUIAN TRIBE IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

SECTION 2. DECLARATION OF POLICY. It is hereby declared that the policy of the Municipality of Nueva Era, Ilocos Norte is to recognize the great and significant contributions of a selfless public servant, **(the late JOSEPH B. ARZADON)** in reforestation and afforestation initiatives in the conservation, preservation and protection of the environment in the Province of Ilocos Norte particularly in the Municipality of Nueva Era that nurtured a balanced and healthful ecology in accordance with the rhythm and harmony in nature. Towards this end, the vital role and importance of a healthy environment in ecological stability is recognized and there is a need for a collaborated effort between the citizenry and the local government unit to combat the depletion of our natural resources and rejuvenate our environment by continuing the efforts of the late JOSEPH B. ARZADON thru massive tree planting

SECTION 3. PROCLAMATION OF JOSEPH B. ARZADON DAY IN THE MUNICIPALITY. In recognition of his great and significant contributions in the reforestation, afforestation, protection and maintenance of idle and forest land of the Municipality of Nueva Era, Ilocos Norte, the **JOSEPH B. ARZADON DAY** shall be declared every 19th day of June every Year and conduct the TREE PLANTING ACTIVITY (firewood, fruit bearing & timber) AND ENSURE THE PARTICIPATION OF ALL STAKEHOLDERS IN THE COMMUNITY.

SECTION 4. MASSIVE TREE PLANTING. The Municipal Officials and employees, barangay officials, sangguniang kabataan, barangay volunteers, katipunan ng kabataan/other youth organizations and other stakeholders shall be responsible for the tree planting activities and its maintenance.

SECTION 5. APPROPRIATIONS. Funding requirements in the implementation of this ordinance shall be incorporated in the Annual Budget of the municipality.

SECTION 6. REPEALING CLAUSE. All Ordinances, resolutions and other issuances inconsistent with the provision of this ordinance are hereby repealed and modified accordingly.

SECTION 7. SEPARABILITY CLAUSE. If for any reason, any provision of this Ordinance is declared invalid or unconstitutional by appropriate agency or office, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.



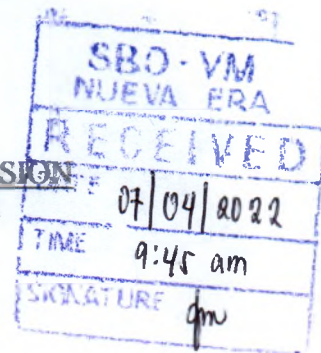
