WHEREAS, Republic Act 9165 otherwise known as the Comprehensive Dangerous Drugs Act of 2002 states that: "It is the policy of the State to safeguard the integrity of its territory and the well-being of its citizenry particularly the youth, from the harmful effects of dangerous drugs on their physical and mental well-being, and to defend the same against acts or omissions detrimental to their development and preservation. In view of the foregoing, the State needs to enhance further the efficacy of the law against dangerous drugs, it being one of today's more serious social ills

WHEREAS, RA 9165 also provides the State to provide effective mechanisms or measures to reintegrate into society individuals who have fallen victims to drug abuse or dangerous drug dependence through sustainable programs of treatment and rehabilitation.

WHEREAS, the Anti-drug Abuse Council has presented plan for its implementation to address the emerging issues of using prohibited drugs and other programs for anti drug campaign;

WHEREAS, after consultation and thorough review of the Anti-drug Abuse Council Plan, this Body hereby:
