RESOLUTION NO. 2023-142

A RESOLUTION AUTHORIZING THE UTILIZATION OF FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (FALGU) AMOUNTING TO THREE HUNDRED MILLION PESOS (PHP300,000,000.00) FOR THE REPAIR AND REHABILITATION OF VARIOUS FLOOD CONTROL PROJECTS AND NATIONAL ROADS IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, the struck of Super Typhoon Egay within the Province of Ilocos Norte and northern Luzon had caused severe flashfloods and massive destruction of properties, agricultural farmlands and infrastructure projects particularly flood controls and roads in the different barangays of the Municipality;

WHEREAS, the immediate repair and restoration of these damaged properties is urgently needed for the general welfare of the constituents and to avoid further destruction and loss of lives and properties;

WHEREAS, the National Government had allocated Financial Assistance to Local Government Units (FALGU) to address the immediate repair and restoration of these damages;

WHEREFORE, BE IT ENACTED BY THE SANGGUNIANG BAYAN OF NUEVA ERA, ILOCOS NORTE, THAT:

RESOLVED, AS IT IS HEREBY RESOLVED TO AUTHORIZE THE UTILIZATION OF FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (FALGU) AMOUNTING TO THREE HUNDRED MILLION PESOS (PHP300,000,000.00) FOR THE REPAIR AND REHABILITATION OF VARIOUS FLOOD CONTROL PROJECTS AND NATIONAL ROADS IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE TO WIT:
