RESOLUTION NO. 2023-144

A RESOLUTION ADOPTING EXECUTIVE ORDER NO. 39 RE: IMPOSITION OF MANDATED PRICE CEILINGS ON RICE.

WHEREAS, Section 2 of Republic Act No. 7581 or the "Price Act", as amended by RA No. 10623, declares it a policy of the State to provide effective and sufficient protection to consumers against hoarding, profiteering and cartels with respect to the supply, distribution, marketing and pricing of goods during periods of calamity, emergency and widespread illegal price manipulation, and other similar situations;

WHEREAS, Section 2 of RA No. 10845 or the "Anti-Agricultural Smuggling Act of 2016" , mandates the State to promote the productivity of the agriculture sector and to protect the farmers from unscrupulous traders and imports, who by their illegal importation of agricultural products, specially rice, significantly affect the production, availability of supply and stability of prices, and the food security of the State;

WHEREAS, uncontrolled prices of rice had threatened the public which affects the economic condition of the consumers;

WHEREAS, to address the concerns of the consuming public, His Excellency President Ferdinand Romualdez Marcos Jr. had issued an order imposing mandated price ceilings on rice;

WHEREFORE, be it enacted by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that...

RESOLVED, AS IT IS HEREBY RESOLVED TO ADOPT EXECUTIVE ORDER NO. 39 RE:IMPOSITION OF MANDATED PRICE CEILINGS ON RICE; and

RESOLVED FINALLY, to furnish copies of this resolution to all concerned agencies for their information and appropriate action.
