A RESOLUTION APPROVING AND ADOPTING THE CY 2024 DISASTER RISK REDUCTION AND MANAGEMENT (DRRM) PLAN OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, Section 16 (General Welfare) of Republic act 7160 otherwise known as the Local Government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain pace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, RA 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 provides for the development of policies and plans and the implementation of actions and measures pertaining to all aspects of disaster risk reduction and management, including good governance, risk assessment and early warning, knowledge building and awareness raising, reducing underlying risk factors and preparedness for effective response and early recovery;

WHEREAS, after consultation and thorough review of the Disaster Risk Reduction and Management Plan, this Body hereby:

RESOLVED AS IT IS HEREBY RESOLVED TO APPROVE AND ADOPT THE CY 2024 DISASTER RISK REDUCTION AND MANAGEMENT (DRRM) PLAN OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE; and
