

## ORDINANCE NO.2 Series 2023

**“AN ORDINANCE OF APPROVING THE OPENING OF ROAD WITH AT PUROK SUERTE WITH AN APPROPRIATE WIDTH OF 5 METERS AND LENGTH OF 50 METERS AT BARANGAY BARIKIR”**

**BE IT ORDINANCED BY THE BARANGAY COUNCIL OF BARIKIR, NUEVA ERA, ILOCOS NORTE, ASSEMBLED IN SESSIONS, THAT:**

**SECTION I. LEGAL BASIS:** SECTION 21 (a) states that “a local government until may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park or square falling within its jurisdiction.

**SECTION II. DECLARATION OF POLICY:** It is the policy of the state to ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote mobility among the residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

**SECTION III. OPENING AND DECLARATION OF THE ROAD:** In support to the development project of the barangay, the alley going to National Road, approximately measuring 50 meters width and 5 meters length, is hereby declared as barangay road when opened or widened, to be maintained by the barangay covering the same.

**SECTION IV. SEPARABILITY CLAUSE:** If any provision, section or part of this ordinance is declared invalid, suspended or revoked by a court of competent jurisdiction, the remaining provisions shall continue to be in full force and effect.

**SECTION V. EFFECTIVITY:** This ordinance shall take effect immediately upon approval.


