**RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE ATTY. ALDRIN R. GARVIDA TO NEGOTIATE AND ENTER INTO A DEED OF EXCHANGE THE 60,157 SQUARE METERS MORE OR LESS, PORTION OF LOT NO. 585 LOCATED AT BRGY. POBLACION, NUEVA ERA, ILOCOS NORTE, OWNED BY THE MUNICIPALITY WITH EQUIVALENT AREA AT LOT 555 OWNED BY ORLY CALAYEG ET. AL.**

**WHEREAS**, an area of 60,157 square meters, more or less, within Lot 585-Part located at Brgy. Poblacion, Nueva Era, Ilocos Norte owned by the municipality of Nueva Era, was formerly used as the breeding station;

**WHEREAS**, the available site that is appropriate and suitable for the establishment of sanitary landfill was within Lot 555 located at Brgy. Poblacion, Nueva Era, Ilocos Norte which was owned by Orly Calayeg et. al;

**WHEREAS**, there is a need to exchange the lot owned by the Municipality with Lot 585 with an equivalent area of 60,157 square meters for the establishment of a sanitary landfill in order to have a proper waste disposal in the municipality

**WHEREFORE**, be it enacted by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that;

**RESOLVED AS IT IS HEREBY RESOLVED TO AUTHORIZE THE LOCAL CHIEF EXECUTIVE ATTY. ALDRIN R. **RESOLVED FINALLY**, to furnish copies of all authorities concerned for their information and guidance.


